Affidavit of Broc Montgomery, MBA MSEd

I am over the age of 18, and a resident of the state of Illinois. I have personal knowledge of the facts herein, and if called as a witness could testify completely thereto. I suffer no legal disabilities and have personal knowledge of the facts set forth below:

- 1. Agencies, individuals, and organizations included but not limited to: President of the United States; Vice President of the United States, United States Department of Justice; United States District Court for Northern District; United StatesSenators Tammy Duckworth and Richard Durbin; United States Representatives Janet Schakowsky; Southern Poverty Law Center; Equal Justice Initiative; National Association for Advancement of Colored People (NAACP); Independent News Media outlets and reporting organizations; AFL-CIO; Anti-Defamation League; Illinois State Police Divisions of Investigation; Illinois Attorney General Office; Bartlett Fire Protection District Local 134, United States police, fire, and labor unions; Collegiate and Professional Sports Organizations; College law programs; and Women, Children Protective, and Father's Rights Advocacy groups.
- 2. My name is Broc Montgomery, Black-Jewish male, age fifty-one (51), at the time of this communication. My education includes a Bachelors of Arts in Sociology emphasis Criminal Justice, minor in business administration (Eastern Illinois University, Charleston, IL); Masters in Business Administration emphasis in Organizational Behavior and leadership (University of Phoenix, Schaumburg, IL); Masters of Science in Education focused in Montal Health Counseling Psychology (Northern Illinois University, Dekalb, IL);
- This affidavit is in addition to a prior affidavit dated February 22, 2022. Patterns and practices of discrimination towards myself, a protected class citizen under federal laws, has been experienced in Dupage County Courthouse, 505 N.
 County Farm Rd, Wheaton, IL 60187 since 2015:
- 4. Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, II. 60187 continues to fraudulently assemble actions for further ongoing discriminatory practices and obstruct justice that includes the engagement of additional courthouses known for similar discriminatory practices within the State of Illinois, severely impacting me directly as well as my elderly parents and family members employment opportunities, real estate transactions, intentionally damaging financial credit opportunities, and obstructing availability to public accommodations throughout the State of Illinois;
- Further intimidation tactics include court fraud, obstructing access to \$60,000+ of legal monies owed, and disruptive arrosts has severely damaged my financial status, mental wellbeing, & opportunities further employment, due to Dupage

County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187 that is repeatedly obstructing access to court ordered finances through agreed maintenance, of high net worth, one percent earner in Illinois, divorce proceedings 2015D1867;

- 6. The patterns and practices of arrests, false arrests, intentional misrepresentations by states attorneys, no due process, suppressed First Amendment Rights, obstructing the fair and appropriate ability for defense in hearings, combined with unusually extensive detainments, coincide with severely high bond amounts by Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187. Comparatively, neighboring counties, with similar arrests. Threats to a Political Official, produce significantly less bonds, reduced processing and time spent in jail. These discriminatory actions by The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187 has now resulted in being black Listed in State of Illinois for employment opportunities, rendering financial difficulties to cover needed living and healthcare expenses.
- A May 6, 2020, arrest, combined with an original \$700,000 bond for an alleged "Threatening a Politician" to exiting
 Dan Cronin, has resulted on May 6, 2020, my termination by Cogent Communications. A \$75,000 base salary with a \$150,000
 plus commissions employment opportunity. To date Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187
 has patterned practices to further impede and discriminate, intentionally, to impact the ability to secure employment in my
 latest masters degree in counseling. The intentional patterns and practices of discrimination throughout civil and criminal
 proceedings in Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187, has caused irrevocable financial
 damages through all employment opportunities, living situations, credit opportunities, and lose of personal transportation;
- 8. Extensive bail amounts of \$700,000 on both May 6, 2020, and recent detainment September 12, 2022, having a \$500,000, without cause, both scenarios prevented keeping existing gainful employment as well as enable to secure new employment. Meanwhile, Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187, actively obstructing Civil Court Orders 2015D1868 for Nichole Renee Buckmaster Montgomery, earning approximately \$1.3 million in yearly from publicly traded company Lamb Weston, Boise, Idaho. The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL, 60187 continues these patterns and practices of obstructing through association with former States Attorney, Brian Nigohosian, personal attorney for 2015D1868 Plaintiff Nichole Renee Buckmaster Montgomery. Actions by attorney Brian Nigohosian include an active interference and collusion in criminal cases 2018OP590, 19DV360, 20DV32, and 20CF823, while obstructing a bi-weekly a one thousand seven hundred dollar (\$1700) maintenance payment for 2015D1868. Further causing intentional financial duress, abuses that include mental and financial, patterns and practices that can be tracked to 2015;
- 9. The patterns and practices of discrimination to Broc Montgomery has damaged employment opportunities, real estate transactions, removed access to credit, can be solely attributed to monies owed through the intentional obstruction of court order 2015D1868 through Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187 and subsequent criminal cases 2018OP590, 19DV360, 20DV32, and 20CF823;

- 10. The patterns and practices of discrimination along with Obstruction of Justice, with the clear intent of Financial Duress can be attributed to all of the following proceedings: 2015D1868, 2018OP590, 19DV360, 20DV32, and 20CF823, even an ankle monitor payment enforcement by states attorneys, retaliatory practices for further financial duress which I can not afford due to not receiving court order payments through 2015D1868 The Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL. in conjunction to the inability to secure employment, even at a Jiffy Lube. A complaint had been filed regarding this matter in the United States Federal Court, federal complaint filing (Northern District 1:2020cv05481);
- 10.1 The patterns and practices of discrimination toward a protected class citizen in connection with employment, real estate transactions, access to financial credit, and available of public accommodations are solely attributed to the following financial math calculated in The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187, they do not want the public to observe or even be aware of (Please see attached W2 for Nichole Renee Buckmaster Montgomery):

730,000 (Nichole Renés Buckmaster Montgomery Base Salary)

- 150,000 (Earnings accounted in 2015D1868 by The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187)
\$580,000 per year of Nichole Renee Buckmaster Montgomery's base salary The Dupage County Courthouse, 505 N. County
Farm Rd, Wheaton, IL 60187, is intentionally obstructs (laundered) through civil proceedings;

The Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187 then uses criminal proceedings, 2018OP590, 19DV360, 20DV32, and 20CF823, to intimidate, silence, and harass, through patterns as well as practices of discrimination towards a protected class in connection that has severely damaged employment opportunities, real estate transactions, access to financial credit, and availability to public accommodations such as U46 School District as well as other School Districts in the state of Illinois to observe my joint custody minor child's athletics;

Finances The Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187 does not want you to see:

Divorced 7 years = 580,000 per year of unaccounted base salary for Nichole Renee Buckmaster Montgomery x 7 years divorced = \$4,060,0000 in seven years of unaccounted only base salary of Nichole Renee Buckmaster Montgomery. All civil and criminal judges The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187 are fully aware. Even the current judge has been informed repeatedly on required court check-in sheets that have been directly emailed to him before proceedings:

I am requesting media, agencies, communities, and citizens, to help investigated this ongoing matter since 2015. Seven years of data, intentionally delayed mailed checks, having minor children deliver checks, while obstructing of state and federal services by Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187 that include obstructing court ordered direct deposits for six years, due to 2018OP590. The Dupage County Courthouse, 505 N. County Farm Rd, Wheaton, IL 60187, Attorney Brian Nigohosian, and Nichole Renee Buckmaster Montgomery are all active members in the obstruction racket;

- 11. The Dupage County Courthouse, 505 N. County Farm Rd, Wheaten, IL 60187, and Former States Attorney, now
 Attorney Brian Nigohosian, encouraging of fraudulent mental health misdiagnosis of delusional, to cover my real diagnosis of
 six different Psychiatrist, Intermittent Explosive Disorder, through court proceedings, mental professionals, for the covering
 of Nichole Renee Buckmaster Montgomery's extensive earnings of an estimated \$1.3 million dollars per year through Lamb
 Weston, as a Jewish and Black man, with Mental Health masters degree along with working experiences youth through adult
 counseling, is utterly repulsive, dishonorable, and criminal;

I would also like to be compensated for the backpay as well as the extensive financial damages: caused by Brian Nigohosian, Nichole Renee Buckmaster Montgomery, and The Dupage County Courthouse, 505 N. County Farm Rd. Wheaton, IL 60187 has intentionally caused for this matter through the patterns and practices of discrimination for all financial matters through criminal and civil proceedings for this matter.
